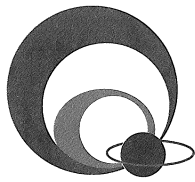

AMENDMENT TO TIMEFRAMES AS STIPULATED IN RESOLUTIONS 9 AND 10 OF 2001

Scope

1. This agreement binds:
 - (a) the employer;
 - (b) the employees of the employer who are members of the trade union parties to this agreement; and
 - (c) the employees of the employer who are not members of any trade union parties to this agreement, but who fall within the registered scope of Council.

Objective

2. The objective of this agreement is to amend Clause 8.2 of Resolution 9 of 2001 as well as Clause 4 of Resolution 10 of 2001.

Parties agree to the following:

3. To convene a Special PSCBC Meeting, which shall remain in session for an uninterrupted period between 15 January 2002 and 31 January 2002 in order to conclude a collective agreement on restructuring.
4. If an agreement on restructuring is not reached by 31 January 2002, parties agree to resort to conciliation, arbitration, strike, lock -out or any other option as provided for in law.
5. This agreement shall come into effect from the date of signing.
6. If there is a dispute about the interpretation or application of this agreement any party may refer the matter to the Council for resolution in terms of the dispute resolution procedure of the Council.
7. The Council will monitor the implementation of this agreement.






